Each GYROVILLE restaurant is named and operated under the principal mark: GYROVILLE.

The total investment necessary to begin operation of a GYROVILLE franchise restaurant is **\$284,350 to \$358,000**. This includes an Initial Franchise Fee of \$25,000.00 as well as opening team expenses ranging from \$2,500.00 to \$3,500.00, which must be paid to the franchisor or an affiliate. This amount does not include development fees under an area development agreement, which may range from \$0.00 to \$1,000,000.00.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in this document.
