Reins USA Franchise Company, Inc. offers franchises for the operation of Japanese style "yakiniiku" restaurants at specified locations offering an assortment of meats, seafood, poultry, vegetables and deserts for customers to cook on state-of-the art charcoal roaster systems, as well as, proprietary dipping sauces, marinades, and a variety of alcoholic and non-alcoholic beverages. The initial franchise fee is \$50,000. The estimated investment necessary to begin operation of a GYU-KAKU franchise unit franchise ranges from \$781,793 to \$2,110,500. This includes from \$60,000 to \$80,000 that is paid to Reins USA Franchise Company, Inc. and its affiliates.
