As a franchisee, you will operate a dental practice support service business through use of our non-clinical Half Dental® office management, marketing and patient procurement systems.

The total investment necessary to begin operation of a Half Dental® franchise is between \$135,300 to \$1,447,400. This includes the \$79,500 to \$154,500 that must be paid to the franchisor or affiliate and the \$0 to \$650,000 that may be paid to an affiliate. To reserve a territory for multi-unit development, the up-front fee is \$5,000 for each unit to be developed.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate regarding the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
