As a commercial logistics center franchisee, you will sell commercial packaging, packing, shipping, moving, pick-up and delivery services, crating and transportation services for large fragile, awkward and valuable freight to commercial and residential customers, and you will sell boxes and packaging materials.

The total investments, ~~initial franchise fees and other~~ payments to us necessary to begin operation of the different types of commercial logistics centers are shown in the table below:
