You will operate an independently owned HAPPYFEET-LEGENDS INTERNATIONAL Franchise that will provide the public with unique soccer education, events and merchandise in a variety of settings and formats. You will provide preschool-day care soccer clinics, soccer leagues, premier and recreational coaching clinics, academies and camps, soccer tournaments, tours and merchandise.

The total investment necessary to begin operation of a HappyFeet-Legends International franchise is \$19,800 to \$23,700. This includes \$13,500 initial franchise fee that must be paid to the franchisor.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign any binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
