You will operate an independently owned HappyFeet-Legends International Franchise that will provide the public with unique soccer education, events and merchandise in a variety of settings and formats. You will provide preschool-day care soccer clinics, soccer leagues, premier and recreational coaching clinics, academies and camps, soccer tournaments, tours and merchandise. All HappyFeet Franchisees will also have the option of offering our Shining Stars drama program that uses fun exercises and games to encourage bravery, confidence, and creativity when communicating with others.

The total investment necessary to begin operation of a HappyFeet-Legends International and Shining Stars franchise is \$22,500 to \$29,400 which includes the investment required to establish the HappyFeet and Shining Stars program. This includes \$15,000 that must be paid to the franchisor.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign any binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
