This Franchise Disclosure Document describes a Happy's Pizza[®] Restaurant unit franchise, a Happy's Pizza and Pub Restaurant unit franchise and a Happy's Pizza[®] area development franchise The Happy's Pizza[®] Restaurant unit franchise is a restaurant business that sells pizza, ribs, chicken, seafood, subs, salads, and other food products to the general public for carry-out, dine-in, catering or delivery The Happy's Pizza and Pub Restaurant unit franchise also sells liquor, beer and wine for on-site consumption The Happy's Pizza[®] area development franchise is a business that will operate at least one unit franchise and will sell and service other unit franchises in a specified territory

The total investment necessary to begin operation of a Happy's Pizza[®] Restaurant unit franchise is from \$336,500 to \$608,000 This includes from \$295,000 to \$525,000 that must be paid to the franchisor or its affiliates. The total investment necessary to begin operation of a Happy's Pizza and Pub Restaurant unit franchise is from \$744,500 to \$1,180,000 This includes from \$385,000 to \$1,035,000 that must be paid to the franchisor or its affiliates. The total investment necessary to begin operation of a Happy's Pizza and Pub Restaurant unit franchise is from \$744,500 to \$1,180,000 This includes from \$385,000 to \$1,035,000 that must be paid to the franchisor or its affiliates. The total investment necessary to begin operation of a Happy's Pizza[®] area development franchise is from \$450,000 to \$1,676,000 This includes from \$395,000 to \$1,525,000 that will be paid to the franchisor or its affiliates.
