This Franchise Disclosure Document describes a Happy's Pizza[®] Restaurant unit franchise. The Happy's Pizza[®] Restaurant unit franchise is a restaurant business that sells pizza, ribs, chicken, seafood, subs, salads, and other food products to the general public for carry-out, dine-in, catering or delivery.

The total investment necessary to begin operation of a Happy's Pizza[®] Restaurant unit franchise is from \$314,380 to \$495,000. This includes from \$295,880 to \$445,000 that must be paid to the franchisor or its affiliates. If you enter into a Multi-Unit Addendum with us, your initial investment will increase by the additional amount of the total initial franchise fees for the unit franchises you commit to develop (e.g. \$25,000 in additional discounted fees if you commit to develop 3 franchises). In that case, your initial investment for a Happy's Pizza[®] Restaurant unit franchise will range from \$365,500 to \$635,000, which includes \$290,000 to \$561,500 that must be paid to the franchisor or its affiliates.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

The terms of your contract will govern your franchise relationship. Don't rely on the disclosure document alone to understand your contract. Read all of your contract carefully. Show our contract and this disclosure document to an advisor, like a lawyer or an accountant.
