The franchisee will operate an Interactive Entertainment Center that includes combat simulation arenas and a gaming lounge for individuals, family entertainment, large group events, parties, corporate team building and law enforcement training under the Marks.

The total investment necessary to begin operations of a Interactive Entertainment Center is from \$549,000 to \$1,256,000. This includes \$155,000 to \$265,000 that must be paid to the franchisor or its affiliates.
