The franchise offered in this disclosure document is for operation of an extended stay guest lodging facility under the Hawthorn Suites by Wyndham<sup>®</sup> brand.

The total investment necessary to begin operation of a typical 96 room Hawthorn Suites by Wyndham facility ranges from \$9,913,574 to \$11,726,092 for a new construction project. The total investment necessary to begin operation of a typical 100-room Hawthorn Suites by Wyndham facility ranges from \$255,977 to \$6,074,721 for conversion of an existing hotel. Land acquisition costs are not included in these ranges. The above amounts include a range of \$54,750 to \$62,650 that must be paid to the franchisor or an affiliate.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale or grant. Note, however, that no governmental agency has verified the information contained in this document.

The terms of your contract will govern your franchise relationship. Do not rely on the Disclosure Document alone to understand your contract. Read all of your contract carefully. Show your contract and this Disclosure Document to an advisor, like a lawyer or an accountant.
