HCAC Franchise, Inc., a Delaware corporation, offers franchises for the operation of Heart Certified Auto Care automotive repair and maintenance business that offer automotive repair and maintenance services to the public under the trade name and service mark "Heart Certified Auto Care". We offer the rights for 2 different franchises in this Disclosure Document:

<u>Single Franchise Program</u>. Under the Single Franchise Program, you will sign a Franchise Agreement to operate one Heart Certified Auto Care automotive repair and maintenance business. The total investment necessary to begin operations of one Heart Certified Auto Care automotive repair and maintenance business ranges from approximately \$279,000 to \$728,000. This includes \$35,000 that must be paid to us or our affiliates.

<u>Area Development Program</u>. Under the Area Development Program, we will assign you a defined area within which you must develop and open 2 or more Heart Certified Auto Care automotive repair and maintenance businesses within a specified period of time. The total investment necessary to begin operations of 2 to 3 Heart Certified Auto Care automotive repair and maintenance businesses under an Area Development Agreement ranges from approximately \$301,500 to \$763,000. This includes between \$55,000 and \$65,000 that must be paid to us or our affiliates.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read the Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payments to the Franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in this document.

You may wish to receive your Disclosure Document in another format that is more convenient for you. 3. YOUR SPOUSE MUST ALSO SIGN A PERSONAL GUARANTEE MAKING YOUR SPOUSE INDIVIDUALLY LIABLE FOR YOUR FINANCIAL OBLIGATIONS UNDER THE FRANCHISE AGREEMENT. THE GUARANTEE WILL PLACE YOUR SPOUSE'S MARITAL AND PERSONAL ASSETS AT RISK IF YOUR FRANCHISE FAILS.
