As a franchisee, you will operate a Franchised Business which may be either a HEIDI'S BROOKLYN DELI® offering traditional deli sandwiches, gourmet desserts and hot and cold beverages; or a SOUP 'N JUICE offering organic products featuring healthy soups, salads, wraps and fruit smoothies; or a Franchised Business from which both a HEIDI'S BROOKLYN DELI® and SOUP N' JUICE® are operated.

The total investment necessary to begin operation of the Franchised Business under the trademark HEIDI'S BROOKLYN DELI® is \$311,667 to \$564,400. This includes \$30,000 paid to the Franchisor or its affiliate. The total investment necessary to begin operation of the Franchised Business under the trademark SOUP N' JUICE® is \$134,500 to \$276,000. This includes \$15,000 paid to the Franchisor or its affiliate. The total investment necessary to begin operation of the Franchised Business under the trademarks HEIDI'S BROOKLYN DELI® and SOUP N' JUICE® combo is \$316,667 to \$569,400. This includes \$35,000 paid to the Franchisor or its affiliate. You will be required to pay our then-current Design Review Fee and then-current Construction Review Fee per Franchised Business you operate. Our current Design Review Fee is \$1000 and our current Construction Review Fee is \$2,500--\$4,000. You may also be required to pay our then-current fee for our corporate schematic if we provide the schematic to you. Our current fee is \$850.
