Help Your Diabetes franchises are business-to-consumer franchises with an operating system that provides marketing, administrative and training services and products, which together serve as a foundation for building and operating an office that assists its patients in becoming clinically non-diabetic and transitioning off of their medications. We offer one type of Help Your Diabetes franchise: individual Help Your Diabetes Franchises for the right to develop and operate a single Franchise or multiple franchises offering all of our franchised services and products in a designated area.

The total investment necessary to begin operation of a single, new Help Your Diabetes Franchise ranges from **\$149,100** to **\$251,600** for each Franchise purchased. This includes the initial franchise fee of \$60,000 to \$100,000 for each purchased, depending on the size of the franchise's designated area, which must be paid to us.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

- THE FRANCHISOR HAS BEEN IN OPERATION FOR A SHORT PERIOD OF 4. TIME (SINCE MAY 2017). THEREFORE, THERE IS NO PRIOR OPERATING HISTORY TO ASSIST YOU IN JUDGING WHETHER OR NOT TO MAKE THIS INVESTMENT.
