 - 1. The total investment necessary to begin operation of a Hemline franchise is approximately \$118,000-\$211,000.** This includes the \$50,000.00 initial Franchise Fee and the \$5,000.00 Application Fee.

Initial Franchise fee:

\$50,000.00 + \$5,000.00 Application Fee

Royalty:

Eight percent (8%) of Net sales

The Application Fee is \$5,000.00; the initial Franchise Fee is \$50,000.00 for each store; the royalty is eight percent (8%) of Net Sales.
