The franchisee will operate a Hissho food outlet specializing in freshly prepared sushi or will operate an Asian food bar.

The total investment necessary to begin operation of a Hissho food outlet is from \$21,050 to \$92,450. This includes \$4,200 for each Hissho food outlet that must be paid to the franchisor.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully.
