The franchise offered is for the establishment and operation of a business providing children with after school hands-on education classes, workshops, private classes, birthday parties, camps and more in the field of hobbies and craftsmanship.

The total investment necessary to begin operations of a Hobby Quest franchise is \$38,925 to \$53,225. This includes initial franchise fee of \$28,000 and minimum equipment purchase of \$3,525 that must be paid to the franchisor or its affiliate.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
