The franchisee will engage in the retail sales of hobby, toy, entertainment, educational, collectible and gift merchandise to the public.

The total investment necessary to begin operation of a HobbyTown®/HobbyTown USA® franchise is (1) \$161,000 to \$210,000 for a Core Concept store, or (2) \$198,000 to \$330,000 for a Comprehensive Model store. This includes approximately (1) \$127,100 to \$163,100 for a Core Concept store or (2) \$158,100 to \$240,600 for a Comprehensive Model store that must be paid to the franchisor or affiliate.

This Disclosure Document summarizes certain provisions of Your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before You sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
