The Holiday Light Company, LLC offers individual franchises for the development and operation of Holiday Light Company by Russel Williams™ businesses ("HLC Businesses") that offer holiday and specialty lighting services.

The total investment necessary to begin operation of an HLC Business is from \$50,750 to \$111,000. This includes \$27,080 to \$42,080 that must be paid to us or our affiliates.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in this document.
