The franchise offered is for the operation of a Holiday Stationstore®. Holiday Stationstores® sell "Automotive Fuels," including gasoline and other motor vehicle fuels, as well as "Groceries, Food Service Items and Merchandise," including foods, groceries, food service items (hot and cold sandwiches, hot dogs, bratwursts, salads, fruit, bakery), convenience store items and general merchandise.

The total investment necessary to begin operation of a new Holiday Stationstore® ranges from \$2,778,600 to \$5,232,600 which includes the following payments made to the Franchisor or its affiliates: 1) Initial Franchise Fee of \$25,000, 2) initial fuel purchase ranging from \$30,000 to \$90,000, 3) initial fuel delivery charges ranging from \$120 to \$2,100, 4) initial purchase of Commissary Products ranging from \$500 to \$2,500, 5) initial training services of \$8,000 to \$10,000, 6) sign lease payments of \$150 to \$550, 7) \$600 charge for credit and authorization terminal and 8) \$2,000 store set-up fee. To convert a pre-existing store, your estimated initial investment ranges from \$791,600 to \$2,342,600. These initial investment estimates assume that you will own the land and building for your Holiday Stationstore®, and include the costs of constructing and equipping an optional car wash.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, us or an affiliate in connection with the proposed franchise sale. Note, however that no government agency has verified the information contained in this document.
