You will operate a business that provides comprehensive care and medical services to home care clients within their home and as supplemental healthcare staff to institutional clients, such as hospitals, retirement facilities and clinics, using the HomeHealth24x7 $\otimes$  business system.

The total investment necessary to begin operation of a HomeHealth24x7  $\mbox{\ }$  franchise is \$85,500 to \$144,700. This includes \$49,000 that you must pay to us or our affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, us in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

1. THE FRANCHISE AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US BY MEDIATION ONLY IN CHARLOTTETOWN, PRINCE EDWARD ISLAND, CANADA AND ARBITRATION ONLY IN BUFFALO, WYOMING. OUT-OF-STATE MEDIATION AND ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO MEDIATE OR ARBITRATE WITH US IN CANADA OR Wyoming THAN IN YOUR OWN STATE.

2. THE FRANCHISE AGREEMENT STATES THAT WYOMING LAW GOVERNS THE CONSTRUCTION AND INTERPRETATION OF THIS AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.

4. WE MAY TERMINATE THE FRANCHISE AGREEMENT IF YOU DO NOT MEET ANNUAL GROSS SALE MINIMUMS IN THE FOLLOWING AMOUNTS: YEAR 1: \$125,000; YEAR 2: \$225,000; YEAR 3: \$325,000; YEAR 4: \$425,000; YEAR 5: 525,000; YEAR 6+: \$525,000 PLUS 10% EACH SUCCESSIVE YEAR.

5. WE MAY TERMINATE THE FRANCHISE AGREEMENT, WITHOUT REFUND, IF YOU DO NOT COMPLETE THE INITIAL TRAINING PROGRAM TO OUR SATISFACTION.

6. YOU WILL BE REQUIRED TO MAKE AN ESTIMATED INITIAL INVESTMENT RANGING FROM \$85,500 to \$144,700. THIS AMOUNT MAY EXCEED OUR STOCKHOLDERS EQUITY AS OF JULY 31, 2016, WHICH IS \$100,000.

- 7. YOU WILL NOT RECEIVE AN EXCLUSIVE TERRITORY.
- 8. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
