The franchise offered is for a Homes & Land Business, or an Estates & Homes Business, both of which offer and sell a complete real estate marketing system for real estate brokers and other professional sellers of residential real estate properties that are "for sale."

The total investment necessary to begin operation of a Homes & Land or Estates & Homes Business is \$47,500 to \$116,000 for a new franchise. This includes \$27,000 that must be paid to the franchisor or its affiliates. The total investment necessary to begin operation of a Homes & Land or Estates & Homes Business is \$19,900 to \$69,000 for an expansion franchise. This includes \$8,000 that must be paid to the franchisor or its affiliates. The total investment necessary to begin operation of a Homes & Land or Estates & Homes Business is \$12,500 to \$96,500 for a Converting Distributor.

This disclosure document summarizes certain provisions of your franchise agreement and other agreements and information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the awarding of the franchise. Note, however, that no governmental agency has verified the information contained in this document.

1. THE FRANCHISE AGREEMENT STATES THAT GEORGIA LAW GENERALLY GOVERNS THE AGREEMENT, EXCEPT FOR APPLICABLE FRANCHISE LAWS OF OTHER STATES. GEORGIA LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
2. THE FRANCHISE AGREEMENT REQUIRES THE FRANCHISEE TO ARBITRATE DISPUTES WITH THE FRANCHISOR ONLY IN THE STATE IN WHICH WE HAVE OUR PRINCIPAL PLACE OF BUSINESS WHEN THE ACTION IS INITIATED. OUT-OF-STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. THE MINIMUM PUBLICATION REQUIREMENTS (INCLUDING ANNUAL PAGE LEVELS AND QUANTITY OF BOOKS PUBLISHED) WILL VARY FROM FRANCHISE TO FRANCHISE. THE PUBLICATION REQUIREMENTS WILL BE DETERMINED BY THE FRANCHISOR IN ITS DISCRETION. THIS INFORMATION WILL BE PROVIDED TO YOU AND INCLUDED IN THE FRANCHISE AGREEMENT BEFORE YOU SIGN THE FRANCHISE AGREEMENT.
4. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.

We use the services of one or more franchise brokers or referral sources to assist us in selling our franchise. A franchise broker or referral source represents us, not you. We pay this person a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of the franchise.
