CONTRACTORS MUST BE LICENSED BEFORE SUBMITTING BIDS.
- 4. THE FRANCHISEE WILL BE REQUIRED TO MAKE AN ESTIMATED INITIAL INVESTMENT RANGING FROM \$98,700 TO \$298,500. THIS AMOUNT EXCEEDS THE FRANCHISOR'S STOCKHOLDERS EQUITY AS OF DECEMBER 31, 2011, WHICH IS MINUS \$73, 219.
- 5. THERE MAY BE OTHER RISKS CONCERNING THE FRANCHISE.
