HomeTask, Inc. ("HomeTask") offers franchises to operate a business of providing a service for home and property owners, renters, businesses and others. HomeTask franchises Lawn Army and Yellow Van Handyman brands of service.

The total investment necessary to begin operation of a Lawn Army or Yellow Van Handyman franchise is from \$8,999 to \$13,999. This includes a \$7,999 initial franchise fee that you must pay to us.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**
