The Full Franchises and Associate Franchises offered are for the right to operate a business to buy, sell and rehabilitate residential and commercial properties and provide certain services to buyers and sellers. Full Franchises are for those persons who will operate the franchise on a full-time basis. Associate Franchises are generally for those persons who desire to operate the franchise on a part-time basis.

The total investment necessary to begin operation of a Full Franchise HomeVestors Business is \$80,300 to \$346,250 This includes \$50,000 that must be paid to the franchisor or affiliate

The total investment necessary to begin operation of an Associate Franchise HomeVestors Business is \$42,300 to \$240,250 This includes \$15,000 that must be paid to the franchisor or affiliate

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale.
