The total investment necessary to begin operation of a newly constructed 109 suite Homewood Suites by Hilton hotel, excluding real property, is \$9,889,0009.874,500 to \$19,551,500,20,475,750 including up to \$199.500255,750 that must be paid to us or our affiliates.

IF THE COURT REJECTS THESE VENUE SELECTIONS, THEN SUIT MAY BE BROUGHT IN NEW YORK, NEW YORK. OUT OF STATE LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST MORE TO SUE US IN NEW YORK OR VIRGINIA THAN IN YOUR HOME STATE.
