An Honest franchisee will operate a fast-casual service restaurant specializing in the sale of freshly prepared, non-frozen, Indian street food dishes cooked to order and related menu items, in a traditional Indian restaurant, cafeteria or canteen setting, and available for consumption at the restaurant or through catering, delivery and/or carry-out

The total investment necessary to begin operation of a single Honest franchise is from \$272,900 to \$409,550 (not including real property), including \$45,000 to \$65,000 that must be paid to the franchisor or its affiliate. The total investment necessary to begin operation of a multi-unit Honest franchise is from \$42,500 to \$69,000 (assuming, for the low end of the range, 5 Honest restaurants and, for the high end of the range, 8 Honest restaurants, although this is not a maximum), including \$37,500 to \$60,000 that must be paid to the franchisor or its affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale.
