An Honest franchisee will operate a fast-casual service restaurant specializing in the sale of freshly prepared, non-frozen, Indian street food dishes cooked to order and related menu items, in a traditional Indian restaurant, cafeteria or canteen setting, and available for consumption at the restaurant or through catering, delivery and/or carry-out

The total investment necessary to begin operation of a single Honest franchise is from \$394,900 to \$598,550 (not including real property), including \$65,000 to \$85,000 that must be paid to the franchisor or its affiliate. The total investment necessary to begin operation of a multi-unit Honest franchise is from \$42,500 to \$69,000 (assuming, for the low end of the range, 5 Honest restaurants and, for the high end of the range, 8 Honest restaurants, although this is not a maximum), including \$37,500 to \$60,000 that must be paid to the franchisor or its affiliate.
