The franchise offered is to operate a HoneyCuts hair salon, which offers haircuts primarily to men and boys in an old time barbershop atmosphere.

The total investment necessary to begin operation under an Area Development Agreement is \$202,800 to \$210,100. This includes \$40,000 to \$47,500 that must be paid to the franchisor or affiliate. The total investment necessary to begin operation of a HoneyCuts hair salon is \$192,800. This includes \$30,000 that must be paid to the franchisor or affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale.
