- 4 IF YOU FAIL TO ACHIEVE MINIMUM GROSS SALES WE MAY ALSO ALLOW ANOTHER FRANCHISEE TO ADVERTISE AND SERVICE CUSTOMERS IN YOUR TERRITORY
- THE FRANCHISOR IS AT AN EARLY STAGE OF DEVELOPMENT AND HAS A LIMITED OPERATING HISTORY THIS FRANCHISE COULD BE A HIGHER RISK INVESTMENT THAN A SYSTEM WITH A LONGER OPERATING HISTORY
- THE FRANCHISOR HAS BEEN IN EXISTENCE FOR A SHORT PERIOD OF TIME, SINCE SEPTEMBER 2015 THEREFORE, THERE IS ONLY A BRIEF
