The franchise offered is for the establishment and operation of a business that offers, markets, promotes, advertises, manages and performs commercial exhaust hood system and oven cleaning, inspection, maintenance, preventative maintenance, repair and restoration services, as well as other products and services authorized by us, currently including, but not limited to, specifically the cleaning, maintenance, replacement, and repair related to the facilities and equipment surrounding commercial kitchens, such as commercial kitchen equipment and appliances, exhaust hood systems, pressure washing, grease and air filters, grease containment and grease tanks, for establishments where food is prepared and/or served at retail (each, a “Retail Food Service Customer” or “RFSC”), as well as other services authorized by us under our marks, utilizing the HOODZ business system, which is sometimes referred to below as the “Franchise”, or “HOODZ Business.”

The total investment necessary to begin operation of a HOODZ Business with a Standard Territory is \$62,561 to \$179,840. This includes \$33,200 to \$109,800 that must be paid to the franchisor or its affiliates. The total investment necessary to begin operations of a HOODZ Business with an Express Territory is \$80,161 to \$137,810. This includes \$49,800 to \$67,770 that must be paid to the franchisor or its affiliates. The total investment necessary to begin operations of a conversion HOODZ Business is \$62,521 to \$144,766. This includes \$32,200 to \$74,800 that must be paid to the franchisor or its affiliates.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**

The terms of your contract will govern your franchise relationship. Don’t rely on the disclosure document alone to understand your contract. Read all of the contract carefully. Review your contract and this disclosure document with an advisor such as a lawyer or an accountant.

Buying a franchise is a complex investment. The information in this disclosure document can help you make an informed decision. ## How to Use This Franchise Disclosure Document

Here are some questions you may be asking about buying a franchise and tips on how to find more information:

QUESTION	WHERE TO FIND INFORMATION
<b>How much can I earn?</b>	Item 19 may give you information about outlet sales, costs, profits or losses. You should also try to obtain this information from others, like current and former franchisees. You can find their names and contact information in Exhibits F and G.
<b>How much will I need to invest?</b>	Items 5 and 6 list fees you will be paying to the franchisor or at the franchisor's direction. Item 7 lists the initial investment to open. Item 8 describes the suppliers you must use.
<b>Does the franchisor have the financial ability to provide support to my business?</b>	Item 21 or Exhibit B includes financial statements. Review these statements carefully.
<b>Is the franchise system stable, growing, or shrinking?</b>	Item 20 summarizes the recent history of the number of company-owned and franchised outlets.
<b>Will my business be the only HOODZ Business in my area?</b>	Item 12 and the "territory" provisions in the franchise agreement describe whether the franchisor and other franchisees can compete with you.
<b>Does the franchisor have a troubled legal history?</b>	Items 3 and 4 tell you whether the franchisor or its management have been involved in material litigation or bankruptcy proceedings.
<b>What's it like to be a HOODZ franchisee?</b>	Exhibits F and G lists current and former franchisees. You can contact them to ask about their experiences.
<b>What else should I know?</b>	These questions are only a few things you should look for. Review all 23 Items and all Exhibits in this disclosure document to better understand this franchise opportunity. See the table of contents.
