As a franchisee, you will operate a HOTWORXTM location as a 24-hour studio that offers hot exercise services, fitness products and other specialty items under the name brand "HOTWORXTM".

The total investment necessary to begin operation of a single HOTWORXTM studio franchise is from \$77,000 to \$213,350. This includes \$71,149 to \$122,595 that must be paid to the franchisor or affiliate.

The total investment necessary to enter into our Area Development Agreement will depend on the actual development rights we grant to you. If we grant you the right to open two additional studios, then your initial investment will range from \$97,000 to \$233,350. This includes \$91,149 to \$142,595 that must be paid to the franchisor or affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.
