The business trademark is the name House of Bread

The franchisee will operate a specialty bread bakery cafe offering healthy, low-fat, and deliciously baked goods and sandwiches

The total estimated initial investment ranges from \$157,000 to \$347,000 for one unit. The one unit is the House of Bread Senior bakery cafe. This includes the franchise fee that is paid to the franchisor. The initial franchise fee is \$35,000 for one franchise. HOB does offer a Multi-Unit franchise agreement. The first franchise unit is \$35,000, the second unit is \$17,500 and third through the eighth unit is \$10,000. The minimum franchise fee for a multiple unit franchise agreement of two units is \$52,500 and the maximum franchise fee for a multiple unit franchise agreement of eight units is \$127,500.
