

## FRANCHISE DISCLOSURE DOCUMENT

The franchisor's name is Dynaco Franchising, Inc. It is a California corporation. Its principal business address is 7050 N. Fresno St., Ste. 210, Fresno, California 93720, telephone number (559) 485-8520.

The franchised business is a restaurant business serving breakfast, lunch and dinner during the hours of 6:00 A.M. to 3:00 P.M.

The total investment necessary to begin operation of a "Huckleberry's" franchise is between \$403,000 and \$648,750. This includes \$35,000 that must be paid to the franchisor or affiliate.

The terms of your contract will govern your franchise relationship. Don't rely on the disclosure document alone to understand your contract. Read all of your contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or an accountant.
