The franchisee will engage in the business of owning and operating a sit-down restaurant specializing in Asian-style food cooked on a grill with an upscale but casual ambiance.

The total initial investment for your Traditional Unit HuHot Restaurant ranges from \$777,000 to \$977,000, including \$40,000 you must pay the franchisor. The total initial investment for your Express Unit HuHot Restaurant ranges from \$482,000 to \$627,000, including \$40,000 you must pay the franchisor. The total initial investment for an Area Development Agreement is \$1,574,000 to \$1,934,000 for 2 restaurants, and \$3,935,000 to \$4,885,000 for 5 restaurants, including \$100,000 to \$250,000 you must pay the franchisor (including the initial investment for each Restaurant you open).

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**

IT MAY ALSO COST MORE TO LITIGATE OR ARBITRATE WITH US IN MISSOULA, MONTANA THAN IN YOUR HOME STATE.
