We offer area representative franchises for the right to refer franchisees to us and obtain the right of first refusal to open and operate quick serve restaurants featuring a variety of quality glazed, frosted, filled and other donuts, specialty coffee, coffee blends and related products under the mark "Humble Donut Co."

The total investment necessary to begin operation of a Humble Donut Co. area representative franchise is between \$208,750 and \$488,200 based on an ARA Territory of between 1 and 10 proposed outlets to be opened and an area development of a minimum of 3 outlets. This includes between \$64,050 to \$154,100 that must be paid to the franchisor or its affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

2. THE AREA REPRESENTATIVE AGREEMENT STATES THAT OKLAHOMA LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
3. THE FRANCHISE OWNERS AND THEIR SPOUSES MUST EACH SIGN PERSONAL GUARANTIES MAKING EACH SPOUSE JOINTLY AND SEVERALLY LIABLE FOR ALL OBLIGATIONS OF THE FRANCHISE. THESE GUARANTIES PLACE EACH FRANCHISE OWNER'S AND EACH SPOUSE'S PERSONAL AND MARITAL ASSETS AT RISK.
4. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
