The Area Representative Franchise offered consists of an Area Representative business in which the Franchisee will be operating a professional services business overseeing the management and coordination of independent restaurant and fast casual QSR franchises in their respective market. The business will be primarily focused on selling and managing unit franchises in the territory. The unit franchised business is to operate a QSR restaurant service business under the trade name "Hummus Republic."

The total investment necessary to begin operation of a The Hummus Republic Area Development is \$86,200 to \$247,400. This includes \$75,000 to \$225,000 that must be paid to the franchisor or affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. IF WE AND YOU CANNOT AGREE ON A SITE, AND IF WE DO NOT AGREE TO EXTEND THE DEADLINE, YOU WILL BE IN DEFAULT AND WE MAY TERMINATE YOUR FRANCHISE AGREEMENT.
 - 5. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.

We may use the services of one or more FRANCHISE BROKERS or referral sources to assist us in selling our franchise. A franchise broker or referral source represents us, not you. We pay this person a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of the franchise.
