This disclosure document describes franchises for friendly neighborhood restaurants specializing in the sale of fresh chicken wings, prepared in a variety of flavors, and other tasty menu items under the name "HURRICANE GRILL & WINGS" (the "HURRICANE GRILL & WINGS Restaurants").

The total investment necessary to begin the operation of a HURRICANE GRILL & WINGS Restaurant ranges from \$300320,000 to \$880895,000. This range includes an initial franchise fee of \$30,000 that must be paid to us. If you sign a Development Agreement to develop multiple HURRICANE GRILL & WINGS Restaurants, you will have to pay us a development fee of \$30,000 for the first restaurant and \$15,000 for each additional restaurant to be developed. Of the development fee that you pay \$30,000 will be applied to the franchise fee for your first restaurant and the balance will be applied in \$15,000 increments against additional franchise fees.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, us or our affiliates in connection with the proposed franchise sale or grant. Note, however, that no governmental agency has verified the information contained in this document.

You may wish to receive your disclosure document in another format that is more convenient for you. The terms of your franchise agreement will govern your franchise relationship. Don't rely on the disclosure document alone to understand your franchise agreement. Read all of your franchise agreement carefully. Show your franchise agreement and this disclosure document to an advisor, like a lawyer or an accountant.

Buying a franchise is a complex investment. The information in this disclosure document can help you make up your mind. THE FRANCHISE AGREEMENT AND THE DEVELOPMENT AGREEMENT REQUIRE THAT CERTAIN DISAGREEMENTS BE OR LITIGATED WHERE WE HAVE OUR PRINCIPAL PLACE OF BUSINESS, WHICH IS CURRENTLY IN PALM BEACH COUNTY, FLORIDA. OUT OF STATE LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO LITIGATE WITH US IN FLORIDA THAN IN YOUR HOME STATE.
- 2. THE FRANCHISE AGREEMENT AND DEVELOPMENT AGREEMENT STATE THAT FLORIDA LAW GOVERNS THE AGREEMENTS, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
- 3. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.

We use the services of one or more FRANCHISE BROKERS or referral sources, and one or more independent "area directors" who operate as franchise brokers or referral sources to assist us in selling our franchise. A franchise broker, area director, or referral source represents us, not you. You should be sure to do your own investigation of the franchise.
