The franchise offered is to operate an upscale, extended stay Hyatt House Hotel.

The total investment necessary to begin operation of a Hyatt House Hotel ranges from ~~\$12,332,500~~13,260,000 to ~~\$17,687,000~~18,366,000. This includes ~~\$109,600~~109,900 to ~~\$142,100~~134,200 that must be paid to the franchisor or affiliate.
