The franchise offered is to operate an upscale, select service Hyatt Place Hotel.

The total investment necessary to begin operation of a Hyatt Place Hotel ranges from \$13,645,000 to \$22,012,500. This includes \$109,900 to \$138,700 that must be paid to the franchisor or affiliate.
