The franchise offered is to operate an upscale, full service Franchise System Hotel under the "Hyatt Regency®" or "Hyatt®" name.

The total investment necessary to begin operation of a Franchise System Hotel ranges from \$33,382,500 to \$128,500,000. This includes \$130,500 to \$1,455,000 that must be paid to the franchisor or affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.
