The total investment necessary to begin operation of a Hyatt Regency Hotel ranges from \$44,348,500 to \$153,763,000. This includes \$294,050 to \$1,806,550 that must be paid to the franchisor or affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully.
