We offer franchises for the operation of businesses offering agricultural pest control, structural pest control, termite control, fumigation, sanitation inspection and related services under the trade name HYDREX.

The total investment necessary to begin operation of a HYDREX franchise ranges from \$36,300 to \$60,700. There is no initial franchise fee that must be paid to the franchisor or an affiliate. This cash investment does not represent your total investment, and you should refer to disclosure items 5-7, inclusive, in this Franchise Disclosure Document for further information regarding the investment.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
