We offer franchises for the operation of businesses that provide agricultural pest control, and commercial and residential structural pest control, termite control, fumigation, sanitation inspection and related services under the trade name Hydrex.

The total investment necessary to begin operation of a Hydrex franchise ranges from \$84,800 to \$130,200. This includes \$35,000 that must be paid to the franchiser and/or its affiliates.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.
