The franchise is for establishment and operation of a mobile pet grooming and pet supply businesses offering the products, services and accessories we designate or approve including primarily pet grooming services and supplies on a mobile basis, under the HydroDog® trade name and business system (a "HydroDog® Business(es)" or "Business(es)").

The total initial investment necessary to begin operation of a single HydroDog® <u>Business</u> ranges from \$142,250 to \$169,600. This includes \$135,300 to \$140,600 that must be paid to the franchisor or affiliate. The total initial investment necessary to begin operation of as an Area Developer ranges from \$22,500 for 3 Businesses and \$37,500 for 5 Businesses that must be paid to the franchisor or affiliate.

This disclosure document summarizes certain provisions of your Franchise Agreement and Development Agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

OUT-OF-STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE WITH US IN FLORIDA THAN IN YOUR OWN STATE.
- 2. THE FRANCHISE AGREEMENT AND AREA DEVELOPMENT AGREEMENT STATE THAT FLORIDA LAW GOVERNS THE AGREEMENTS, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
- 3. WE WERE FORMED ON AUGUST 21, 2014, AND DID NOT COMMENCE FRANCHISING ACTIVITIES UNTIL JANUARY 18, 2018, AND HAVE A LIMITED OPERATING HISTORY. YOU MAY WANT TO CONSIDER THIS WHEN MAKING A DECISION TO PURCHASE THIS FRANCHISE.
