You will operate a business as a restaurant primarily selling pizza by the slice. You will provide the services and products operating under the Marks and using the System.

The total investment necessary to begin operation of an Ian's Pizza by the Slice franchised business is from \$239,000 - \$401,000. This includes an initial fee of \$25,000 that must be paid to the franchisor.

This disclosure document summarizes certain provisions of Your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in this document.

You may wish to receive Your disclosure document in another format that is more convenient for you.
