The total investment necessary to begin operation of an ICE COLD AIR® franchise ranges from \$93,750 to \$458,750. This includes between \$60,250 and \$313,250 that must be paid to the Franchisor and its affiliates. If you operate more than one ICA Franchise, you will pay the same fees for each franchise you operate.

You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**

The terms of your contract will govern your franchise relationship. Don't rely on the Disclosure Document alone to understand your contract. Read your entire contract carefully. Show your contract and this Disclosure Document to an advisor, like a lawyer and/or an accountant.

Buying a franchise is a complex investment. The information in this disclosure document can help you make up your mind.
