As a franchisee, you will operate one of the following: a standard fast food restaurant franchise offering shakes, cones, burgers, fries, sandwiches, drinks, sundaes and other limited menu fast food items; or a shake shop concept which only offers milkshakes, cones and related ice cream products. The shake shop option will only be for non-traditional locations such as an amusement parks, airports, stadiums, malls, etc.

The total investment necessary to begin operation of a standard Iceberg Drive Inn® franchise is between \$223,800 and \$823,200. This includes the \$12,500 - \$17,000 that must be paid to the franchisor or affiliate. The total investment necessary to begin operation of a shake shop Iceberg Drive Inn® franchise is between \$133,300 and \$345,700. This includes the \$10,000 - \$14,500 that must be paid to the franchisor or affiliate. If you enter into a multi-unit franchise agreement for either concept, there is an additional non-refundable development fee of \$5,000 per unit to be developed by you.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate regarding the proposed franchise sale.
