We offer two different franchise programs for restaurants at non-traditional venues which feature "IHOP" pancakes as well as a diverse menu of other breakfast, lunch and dinner items.

The total investment necessary to begin operation of an IHOP franchise at a non-traditional venue is as follows:

Full Service Program	\$643,500	\$3,253,850
IHOP Alternative Service Program	\$245,500	\$1,005,225

This includes Initial Fees of \$25,000 per Full Service restaurant and \$15,000 per IHOP Alternative Service restaurant to be developed which must be paid to the Franchisor or an IHOP Affiliate.

You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. OUT-OF-STATE MEDIATION AND ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO MEDIATE AND ARBITRATE WITH US IN CALIFORNIA THAN IN YOUR OWN STATE.

2. THE IHOP NON-TRADITIONAL MASTER LICENSE AGREEMENT STATES THAT CALIFORNIA LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
