The estimated total initial investment necessary to begin operation of an Affiliate Franchised Image One Cleaning business is from \$37,360 to \$103,950, which includes \$33,150 to \$41,150 you must pay the Franchisor. The estimated total initial investment necessary to begin operation of a Conversion Affiliate Franchised Image One Cleaning business is from \$150 to \$98,950, which includes \$0 to \$11,400 you must pay the Franchisor.
