The estimated total initial investment necessary to begin operation of an Affiliate Franchised Image One Cleaning business is from \$57,110 to \$123,700, which includes \$49,800 to \$57,000 you must pay the Franchisor. The estimated total initial investment necessary to begin operation of a Conversion Affiliate Franchised Image One Cleaning business is from \$150 to \$11,700, which includes \$0 to \$52,000 you must pay the Franchisor.
